## MANAGER, TRANSPORTATION ENGAGEMENT

We are in search of a talented professional based at our Toronto headquarters with extensive experience in public outreach and engagement in support of the implementation and/or ongoing management of a large multi-modal materials transportation program, including understanding social constraints and developing strategies and plans to address them. Reporting to the Director of Community Well-being Assessment & Dialogue and working with a team of social and technical scientists, the Manager, Transportation Engagement will be involved in developing and implementing plans to engage Canadians in the development of a socially acceptable transportation plan for moving used nuclear fuel from the current interim storage locations to the single site which will be selected to host the deep geological repository.

## **Responsibilities:**

- Provide advice and support to the Director, Community Well-being Assessment and Dialogue in the development and successful implementation of transportation engagement throughout communities in the siting process and surrounding areas.
- Contribute to the development of NWMO engagement strategy to build understanding of social acceptance considerations, questions and concerns to inform the development of a social framework for future transportation programs.
- Lead social constraint mapping studies of possible transportation routes to help guide early outreach and engagement activities and decision making;
- Develop and implement detailed engagement work plan with siting communities, transportation hub communities and others as appropriate.
- Work with NWMO Aboriginal Relations engagement team to develop transportation engagement plans with First Nations and Métis communities.
- Work closely with the NWMO transportation technical team to coordinate engagement activities and ensure feedback from engagement is considered in ongoing technical studies as appropriate
- Oversee work of external contractors.

- Work with the communication team to develop outreach material and presentations regarding the NWMO's approach to transportation.
- Represent the NWMO at local transportation engagement activities, public dialogues and events with communities, first responders and relevant key opinion leaders. Undertake presentations and respond to questions, as required.

## **Qualifications:**

- Hold a university degree or equivalent professional experience in transportation. Candidates with a Bachelor degree and 10+ years of experience in transportation safety, transportation planning, and/or transportation emergency management.
- Experience in public engagement and understanding of transportation security and emergency management processes.
- Have proven organizational skills, be a self-starter, and can work in a team environment that is dedicated to excellence.
- Ability to work effectively in a multidisciplinary team environment.
- Strong planning and project management skills.
- Excellent oral and written communication skills.
- Demonstrated background in engaging with communities and the general public in a variety of fora.
- Have an ability to be flexible, and meet new challenges as they arise, in a demanding and dynamic environment.
- Able to travel extensively within Ontario, Quebec and New Brunswick.
- Bilingualism, French and English, is an asset.
