## 4. Update - Engagement Activities

The Chairman invited the President to provide an update to the Advisory Council on the NWMO's most recent engagement activities.

The President outlined the range of submissions forwarded most recently to NWMO that have been reviewed and will be summarized in the NWMO's Final Study Report.

The NWMO's engagement activities from August were discussed.

As part of this update, the President reported on the Elders' Forum convened in Ottawa August 25-27, 2005. Consistent with the suggestions of the Advisory Council, the Forum convened by the NWMO brought together Elders from across Canada, accompanied by young people, to review the work of the NWMO and discuss the draft recommendation put forward by the NWMO. The Forum also provided an opportunity bring some holders of Aboriginal Traditional Knowledge together to review the challenge of managing used nuclear fuel for the long term. Advisory Council members were pleased to hear about the outcome of the Elders' Forum.

The President noted that the reports from the August engagement activities would be posted on the NWMO website along with the other engagement reports.

The Chairman invited general discussion and questions from the Advisory Council.

#### 5. Update – Preparation of Final Study Report

The President reviewed the timelines and process relating to the production of the Final Study Report. The NWMO committed to keep the Advisory Council updated on the communications planning around the release of the Final Study Report.

The Advisory Council Chairman reported to the President that the Council had concluded the drafting of its comments. After some discussion, the Advisory Council concluded that, within the stipulated statutory limits to which it was subject, the NWMO conducted a process that was comprehensive, transparent and clearly exhibits fairness, balance and integrity. The Advisory Council report contains a number of outstanding considerations on the management approach that would need to be addressed as the NWMO proceeds to the next phase of its work. The Advisory Council report provides final thoughts and recommendations, drawing on the experiences of the past three years.

The Chairman noted that the report from the Advisory Council would be formally transmitted to the NWMO, for inclusion in the Final Study Report that is submitted to the Minister of Natural Resources Canada and made public.
